The project, which involves removing the Talbot Mills Dam on the Concord River, requires a 401 Water Quality Certification from MassDEP because it involves a discharge to state waters.

Clean Water Act:

This certification is mandated by the federal Clean Water Act, which gives states the authority to review projects that require federal permits and result in a discharge to state waters.

Purpose of 401 Review:


The purpose of the state 401 review is to ensure that the project will comply with state water quality standards and other relevant requirements of state law.



812 Maple Street, Carlisle Greenough Pond Water Chestnut Removal

Notice of Intent

Hand removal of a moderate amount of invasive Water Chestnut (trapa natans), around 1000 plants as of 2024. It will be composted on in a grassy upland area outside of wetland buffer zones and priority habitat areas prior to disposal with the Department of Public Works. Also, hand removal of <500 sq feet of invasive Glossy Buckthorn (Frangula alnus) for pond access.




