

#### **CPC Application - Carol Getchell Trail Middle Section**

- CPA funds were requested for design services, site engineering, permitting and related documents for the Middle Section of the Carol Getchell Nature Trail (1,833 feet) and Stapleton Stairs
- The funding request for the Stapleton Stairs was withdrawn by the applicant (estimated cost \$33,500)
- Funds will be used for design services of universally accessible trail along the Wild and Scenic Sudbury River to connect the North and South Sections of the trail, which are currently under construction




#### **Mass Central Rail Trail**



- MCRT Sudbury Hudson: This 7.5-mile stretch from Sudbury Substation to Wilkins Street, Hudson/Connection to Assabet River Rail Trail will be built by DCR. Construction will begin in the spring of 2025.
- MCRT Wayland to Sudbury: Route 126, Wayland to Sudbury Substation: This 1.9-mile segment is designed by DCR and will be funded and constructed by MassDOT. Design and permitting is anticipated to be complete in 2026.



### Talbot Mill Dam Billerica, MA

ConCom hearing continued to 5/12/25, ConCom waiting for MA DEP 401 Water Quality Certificate

#### **401 Water Quality Certification:**

The project, which involves removing the Talbot Mills Dam on the Concord River, requires a 401 Water Quality Certification from MassDEP because it involves a discharge to state waters.

#### **Clean Water Act:**

This certification is mandated by the federal Clean Water Act, which gives states the authority to review projects that require federal permits and result in a discharge to state waters.

#### Purpose of 401 Review:

The purpose of the state 401 review is to ensure that the project will comply with state water quality standards and other relevant requirements of state law.
